#### **Overview**

The ION8650 meter has a cell modem option that provides an additional communication method to the meter.

The communications board has been revised to accommodate a cell modem module which can replace the 56k analog modem option. In addition to the new hardware, the meter's firmware contains a new core communications module to provide setup information for the cell modem. Once the connection is successful, you can connect to your meter through one of the cell modem ports using a meter configuration tool such as ION Setup.

The cell modem option is available on all models of the socket meter. The cell modem option is not supported on the switchboard meter.

It is recommended that you upgrade to the latest version of ION Setup to help properly configure the features available on your meter, including the cell modem. Refer to the documents in "Additional information" for detailed instructions and precautions regarding the ION8650 meter.

#### **Features**

- Configure up to six simultaneous connections to the meter using ION, Modbus TCP and DNP 3.0 protocols. The protocol and number for each port are configured through the meter display or ION Setup.
- Configure the cell modem to activate when the account with your cellular carrier is set up for roaming.
- View cell modem information such as IP address and signal strength through ION Setup.
- Set the range of IP addresses that are permitted to connect to the meter. The allowed IPs are configured through ION Setup.
- Enable and disable the cell modem port through the ENABLED COM PORTS menu (ION8650C meter only).
- · Programmable APN.
- Time sync over cell modem for ION and other protocols.

# **Meter options**

All usual meter options are available with the ION8650 cell modem option, including I/O and power supply.

**NOTE:** The 56k analog modem and cell modem are separate ordering options and cannot be on the same meter.


<sup>&</sup>lt;sup>1</sup> The ION8650C meter can only communicate through a maximum of three ports simultaneously (the infrared optical port, plus two other communications ports). The ION8650A and ION8650B meters can communicate simultaneously through all communications ports.

# **Cell modem connection**

With the cell modem option, the communications cable includes one (CDMA) or two (LTE) antenna cables with SMA connectors.

See "Specifications" for information on the antenna that is included with your meter.

 $<sup>^{\</sup>rm 2}$  The cellular modem option is only available on the ION8650 socket meter.



# **Configuration process overview**

Before you can use the ION8650 cell modem, it must be configured.

- Contact the service provider for your area and activate the meter. See "Activating the cell modem" for more information.
- Set port number and protocol for each connection. See "Configuring the cell modem" for more information.
- Set the range of IP addresses that are allowed to connect to the meter. See "Allowed IPs" for more information.

# **Activating the LTE cell modem for Verizon (US provider)**

Verizon will activate your cell modem after you contact them and provide them with your device's information.

Before the cell modem can be activated on your meter, you must request activation with your cellular carrier:

- Locate the International Mobile Equipment Identity (IMEI) number. This
  number can either be found on the label on the side of the meter or by
  connecting to the meter using ION Setup.
- Contact Verizon, provide the IMEI number and modem type and request an activation of the meter's cell modem.
- Open the Setup Assistant for your meter. See the ION Setup for more information.
- 2. Navigate to **Communications > Cellular Settings** and select the **Info** tab.
- 3. Find the IMEI number for the device.

**NOTE:** Once Verizon completes their activation, you may be required to adjust the APN as per Verizon's instructions. After changing the APN, your meter should automatically activate on the network (it may take up to 60 seconds). Instructions to configure the APN are detailed in the section "Viewing and configuring cellular network information using ION Setup".

# Activating the CDMA cell modem for Verizon (US provider) using ION Setup

- Locate the Mobile Equipment Identifier (MEID). This number can either be found on the label on the side of the meter, through the meter display, or by connecting to the meter using ION Setup.
- 2. Contact Verizon, provide the MEID and modem type and request an activation of the meter's cell modem.
- 3. Open the Setup Assistant for your meter. See the ION Setup online help for more information.
- 4. Navigate to **Communications > Cellular Settings** and select the **Info** tab.
- 5. Select Activation Status then click Activate.
- 6. Verify that the IP address shown on the meter matches the IP address issued by the provider.

**NOTE:** It is recommended that when activating your modem, a static IP address is requested. Using a dynamic IP can result in a change of IP address whenever the meter is power cycled.

# Activating the CDMA cell modem for Verizon (US provider) using Telnet/Hyperterminal

- Locate the Mobile Equipment Identifier (MEID). This number can either be found on the label on the side of the meter, through the meter display, or by connecting to the meter using ION Setup.
- Contact Verizon, provide the MEID and modem type and request an activation of the meter's cell modem.
- 3. Activate the cell modem by connecting to the meter with terminal software such as Telnet or Hyperterminal. Once you have successfully logged into the meter, enter cellactivate 1 at the prompt.

**NOTE:** If you are connected to the meter through Ethernet, you must type 9 and press Enter to bring up the debug screen, then enter cellactivate 1 at the prompt to activate the cell modem.

4. Verify that the IP address shown on the meter matches the IP address issued by the provider.

**NOTE:** It is recommended that when activating your modem, a static IP address is requested. Using a dynamic IP can result in a change of IP address whenever the meter is power cycled.

# Configuring the cell modem using the display

Use the display to navigate to the setup menus to perform cell modem setup on your meter.

**NOTE:** The following configuration steps must be completed for the cell modem to function properly.

- 1. Press and hold the **ALT/ENTER** button to access the meter's setup screens.
- Use the up or down arrow buttons to select CELL SETUP and press ALT/ ENTER.

3. Configure the settings (Protocol and Port Number) for each connection.

**NOTE:** To disable the connection to a port, set the Protocol to None. This allows you to restrict the number of simultaneous connections to the meter through the cell modem.

# Configuring the cell modem using ION Setup

You can configure the port number and protocol connections over the associated cellular network through ION Setup.

**NOTE:** The following configuration steps must be completed for the cell modem to function properly.

- 1. Start ION Setup.
- 2. Open the Setup Assistant for your meter.
- 3. Navigate to Communications > Cellular Settings > Connections.
- 4. Select the entry you want to change and click **Edit**. The **Cellular Protocol Options** dialog appears.
- 5. Select the protocol from the dropdown list (ION, Modbus TCP, DNP 3.0), enter the port number associated with the protocol and click **OK**.

# Viewing and configuring cellular network information using ION Setup

You can view information relating to your service provider's cellular network through ION Setup. There are also some settings you can configure.

- 1. Start ION Setup.
- 2. Open the Setup Assistant for your meter.
- 3. Navigate to Communications > Cellular Settings > Info.

IP Address	Displays the TCP/IP address assigned to the meter <sup>1</sup>	Read
MEID/CCID	Displays the SIM card number or MEID (CDMA)	Read
Signal Strength	Displays the cellular signal strength in decibel-milliwatt (dBm)	Read

Allow Roaming	This specifies whether the device is allowed to roam on a different service provider if it is outside their cellular network service provider's coverage	Read/write

APN	Enter the Access Point Name if requested by the cellular network service provider	Read/write
Network	Displays the current network and cellular service provider	Read

**NOTE:** Not all settings are available for all meters.

#### Allowed IPs

Through ION Setup, you can configure the IP addresses that are allowed to be connected to the meter using the cellular network.

This feature allows you to select the IP address range that the cell modem will accept a connection from. If the IP address falls outside this range, a connection cannot be made to the meter through the cell modem.

**NOTE:** This function can only be performed through ION Setup.

# Configuring allowed IPs using ION Setup

- 1. Start ION Setup.
- 2. Open the Setup Assistant for your meter.
- 3. Navigate to Communications > Cellular Settings > Allowed IPs.
- Click Add to add another IP address to the list. The Allowed IP Setup dialog appears. Enter the IP address in the Network IP field using the aaa.bbb.ccc. ddd format.
- 5. Select the applicable network mask from the dropdown list. The addresses provided for the Network IP and the Network Mask define the start and end IP addresses.
- 6. Click OK.
- 7. Select an entry from the list and click **Edit** to modify an existing IP address. The **Allowed IP Setup** dialog appears. Modify the IP address in the Network IP field using the aaa.bbb.ccc.ddd format. Select the applicable network mask from the dropdown list. Click **OK**.
- 8. Select an entry from the list and click **Delete** to remove an IP address from the list. Click **Yes** to confirm.

**NOTE:** A Start IP of 0.0.0.0 and an End IP to 255.255.255.255 allows all incoming connections to the cell modem.

# **ENABLED COM PORTS menu (ION8650C only)**

Up to three COM ports can be active simultaneously on the ION8650C. COM3 (the front optical port) is always enabled. The ENABLED COM PORTS menu allows you to select the other two COM ports that you want enabled. The cell modem is one of those ports.

#### Enabling and disabling the ION8650C cell modem using the display

- 1. Press the **ALT/ENTER** button to enter the SETUP menu.
- Use the arrow buttons to scroll down the menu and select ENABLED COM PORTS, then press ALT/ENTER. Select CONTINUE and press ALT/ENTER when prompted.

- Select CELL MODEM and press ALT/ENTER. Select DISABLED or ENABLED and press ALT/ENTER. If prompted, enter the meter password to confirm the change.
- 4. Select REBOOT and press **ALT/ENTER**. Enter the meter password and confirm the change if prompted.

**NOTE:** Select UNDO & RETURN to exit the ENABLED COM PORTS setup menu without making any changes. Your meter will not reboot.

### Enabling and disabling the ION8650C cell modem using ION Setup

You can enable and disable your meter's cell modem on the ION8650C using ION Setup.

**NOTE:** You must manually power cycle the meter for the changes to take effect.

- 1. Start ION Setup.
- 2. Open the Setup Assistant for your meter.
- 3. Select Communication > Enable/Disable and click the Enabled Ports tab.
- 4. Select the Cellular Modem port.
- Click Edit. Enter the meter password if prompted. The Set Enabled Ports dialog appears.
- Select the checkbox to enable the cell modem, or clear the checkbox to disable it.
- 7. Click **OK** to return to the Setup Assistant. Changes take effect the next time the meter is power cycled, either manually or in a power outage.
